The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law or the land.
- 8. That the school will ensure compliance of all statutory requirements like EPF, ESI, and Labour Laws etc. with respect to the school and staff of the school.
